Subject: Implementation Guidance for Indiana Standards Revisions

Pursuant to Indiana Code (IC) 20-31-3, the Indiana Department of Education (IDOE) reviews Indiana Academic Standards (IAS) at least once every six years. (IC) 20-31-3-1 further requires IDOE to provide recommendations for the reduction of IAS after a research study has been completed that defines essential postsecondary skills to promote enlistment, enrollment, and employment. Details of the revision, implementation, and/or assessment cycles of any revised standards, including English learner standards appear below:

Revision school year: Public comment opens, educator committees recommend revisions, and IDOE presents recommendations for SBOE approval.

Implementation school year: Indiana schools integrate any revised standards into local curricula, students have an opportunity to learn the revised standards, and IDOE field tests assessment items aligned with the revised standards, whenever applicable.

Assessment school year: Any revised standards are assessed operationally on state accountability assessments (e.g., ILEARN, IREAD-3, IAM).
